**Objects and purposes (clause 2)**

The objects and purposes of the Association are as follows:

- (a) To provide comprehensive settlement and multicultural services including information, counselling, referral and support services through the association and in collaborative partnership with other agencies.
- (b) To support, facilitate and promote the philosophy and practice of access and equity and to develop and implement appropriate policies to that effect.
- (c) To provide timely and informed advice to the Department of Immigration and Citizenship (DIAC) and to the Northern Territory Office of Multicultural Affairs (OMA) with respect to the needs and aspirations of emerging communities, newly arrived migrants and refugees, and the development of a harmonious multicultural society in the Northern Territory.
- (d) To coordinate services and activities in the community relating to the early settlement and long term needs of persons from culturally diverse backgrounds in conformity with the principles and policies of access and equity.
- (e) To establish partnerships with government and non-government bodies to enable a targeted and non-discriminatory service delivery to a multicultural community.
- (f) To ensure relevant service delivery to vulnerable groups within culturally and linguistically diverse (CALD) community including the small, isolated and emerging communities.
- (g) To combat racism and discrimination based on ethnic origin or religion, and to promote greater appreciation of the benefits of diversity to Australian society and the richness on contribution of that diversity.
